C. ATHLETE ELIGIBILITY

All athletes must comply with the provisions of the Olympic Charter currently in force, including but not limited to, Rule 41 (Nationality of Competitors). Only those athletes who have complied with the Olympic Charter may participate in the Youth Olympic Games.

Age

To be eligible to participate in the Youth Olympic Games, athletes must have been born between 1 January 2000 and 31 December 2002.





D. QUALIFICATION PATHWAY

QUALIFICATION PLACES

	A dedicated qualification competition for the YOG will be held no later than <date>. The date and location of this event will be confirmed by FINA following the selection of the host country and federation.</date>		
	An NOC may enter a maximum of one (1) diver in each of the four (4) individual events in the YOG qualifying competition.		
	The top nine (9) finishers in each event at the YOG qualifying competition will obtain a quota place for their respective NOC.		
	Team event a) One (1) team will be comprise of one (1) male and one (1) female diver amongst those qualified through the individual events. b) A team may be composed of two athletes from the same NOC. c) FINA may decide on additional teams to compete, made up of athletes from different NOCs in accordance with the event ranking.		

HOST COUNTRY PLACES

The host country will automatically qualify two (2) male and two (2) female, one (1) diver per individual event, on the condition that the athletes participate in the qualification event and meet the eligibility requirements described under point C of this document.

UNIVERSALITY PLACES

Four (4) male Universality Places and four (4) female Universality Places, will be made available to eligible NOCs at the YOG, subject to the athletes meeting the eligibility criteria under section C.

The International Olympic Committee will invite all eligible NOCs to submit their requests for Universality Places (date TBC). The Tripartite Commission will confirm, in writing, the allocation of invitation places to the relevant NOCs, in collaboration with FINA, in March 2017.





E. CONFIRMATION PROCESS FOR QUOTA PLACES

CONFIRMATION OF QUALIFICATION PLACES

By <date>, FINA will confirm to NOCs the qualification places from the YOG Qualifying Competition.

NOCs will then have up to two weeks to confirm in writing to FINA and BAYOGOC the use of the qualification places.

CONFIRMATION OF HOST COUNTRY PLACES

The host country must confirm in writing to FINA and BAYOGOC by <date> the use of its Host Country Places.

F. REALLOCATION OF UNUSED QUOTA PLACES

REALLOCATION OF UNUSED QUALIFICATION PLACES

If a quota place allocated is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated to the NOC(s) of the next best-ranked athlete(s) not yet qualified at the dedicated qualification event.

REALLOCATION OF UNUSED HOST COUNTRY PLACES

Any unused Host Country Places will be reallocated to the NOC(s) of the next best-ranked athlete(s) not yet qualified at the dedicated qualification event.

REALLOCATION OF UNUSED UNIVERSALITY PLACES

Any unused Universality Places, including those returned after the final allocation by the YOG Tripartite Commission, will be reallocated to the NOCs of the next best-ranked athletes not yet qualified at the dedicated qualification event.
